Beaverson Law Group currently has five workstations in house and three virtual workstations to support attorneys and staff that work remotely. Remote access is enabled with a secure VPN that requires multi-factor authentication (MFA) to ensure only authorized employees are allowed access. Now with Secure Managed Services under management by Aunalytics, the firm is confident in the security of its IT infrastructure with services and solutions that include:

"Since deploying Aunalytics' Secure Managed Services, cyberattacks have been nearly non-existent," added Beaverson. "There was an instance, however, when a virus accessed a PC that I use at home and is part of the network. I received a call out of the blue from our dedicated Aunalytics agent, Lincoln Robinson, and he informed me of the threat and immediately began a remediation of the threat. That's the type of service I expect and what I feel like I'm paying for. Our lawyers don't have the time to get sidetracked by these issues, so having Aunalytics on-call has been a high-value addition to our operation."

In addition to operations in Indiana, the firm also has a presence in Florida, where it works with a large number of seniors who, in many cases, list medical details which are protected under HIPAA compliance regulations. Because of this, the firm is responsible for ensuring sensitive HIPAA-protected documents are properly stored and accessed only by the appropriate parties. Aunalytics keeps Beaverson Law Group compliant with these requirements, which has removed their legal team from having to manage this time-consuming process.

Regarding the actual management of IT resources such as hardware and software, Beaverson explains that Aunalytics oversees expiring licenses and upcoming warranty expirations, which is another troublesome activity for the law firm to manage. She added that Aunalytics regularly provides guidance on systems beyond its oversight, such as the firm's printers and copy machines, making sure those items are running smoothly when a company representative visits the office.

"In the case of IT resource management, our Aunalytics representative Lincoln Robinson sent us a spreadsheet a couple of months ago and said we have certain pieces of equipment that are going out of warranty soon. Those products may still be okay, but we were appreciative of the notice as it gave us a chance to look into better technology," Beaverson said. "Lincoln pointed out that at some point, our server will reach a certain age and need to be replaced. He suggested that in our case, we'd be better off moving that server instance to the cloud with 24/7/365 support, instead of buying another difficult to manage physical server." The Aunalytics Enterprise Cloud meets the highest security and compliance standards, including Beaverson's need for keeping attorney-client privileged data secure and for meeting HIPPA compliance. Beaverson has a standing meeting with Aunalytics once a month where upcoming projects are discussed or planned. For example, the future replacement of a server in 2023 was discussed in a recent meeting and the law firm is pleased with this proactive, advanced planning to keep IT systems in top running condition. Outside of the planning, Aunalytics takes care of all the IT, security, and compliance processes in the background so that these items do not burden the Beaverson Law Group's staff. The firm is only contacted when an urgent matter arises, such as conducting a needed security patch on a critical application.

"If we can keep our technology and application patching current, it's much easier for us to manage and ward off potential security threats," said Beaverson. "Aunalytics co-managed Security Patching Platform is another tool in our security defense system since workstation and server application patching ensure that we have baseline protection against the latest vulnerabilities in order to pre-empt an attack."
